The LL.M. in French and European Union Law is taught in English

If English is not your first language, you will need to demonstrate that you have the skills and competencies to take part in class discussions, to understand the complexity of legal lectures and seminars and to succeed in your assignments. You must therefore prove a high knowledge of English to apply to the LL.M. program.

There are three ways to prove your knowledge of English:

- provide an approved proficiency test
- provide an approved international English language qualification
- meet our exemption criteria



I. ENGLISH LANGUAGE PROFICIENCY TESTS

There are many English language tests available, you need to take one of the tests we recognize.

Details of the minimum scores we accept in these tests, and how they compare to IELTS, are listed below.

English language tests should be no more than two years old on the start date of the LL.M. program.
