### About the School of Law

The School of Law is a leading Law School in France, ranked 3rd in France by the French Ministry of Education and 1st in Paris and suburbs by "l'Étudiant", the leading student magazine in France. This dynamic and prestigious School of Law welcomes over 3,000 students and offers "Licence", Master and Doctorate Degrees. It is an International, European and French center for legal education.

The School has developed and multiplied international partnerships and exchanges with foreign universities in Europe, the United States and Australia. At the same time it has also developed bilingual degrees in Anglo-American, English, Spanish and German law. In 2009 the School was awarded the prestigious Tocqueville-Fulbright chair and welcomed Professor Louis Wolcher during several months. The School has also developed a field of expertise in combined degrees:

- ► An intensive detailed Master degree in Contracts and Business Law with Essec Business School. Students spend one semester at UCP and one semester at Essec Business School.
- ► A Master degree of combined French and German Law with the University of Düsseldorf. This degree is followed alternatively in both Universities.
- ► A joint Master 2 Legal Advisor DJCE (UCP)/ LL.M. in Business (Vermont Law School USA).
- ► A joint Master 2 (UCP)/LL.M. (University of Dundee) program. The program is unique and offers two qualifications delivered in two semesters.









## About the University of Cergy-Pontoise

The School of Law is located in Cergy-Pontoise, a suburb of Paris which is conveniently located on the RER A train line with a station that is near the school. This allows for students to easily commute to and from Paris. Ideally located west of Paris in the department of Val d'Oise, it is within a short distance from Paris, 30 minutes from The Arc de Triomphe and The Avenue of the Champs-Elysées.

Since its creation in 1967, the department of Val-d'Oise has become a dynamic center of economic development. Its privileged geographical situation allows it to benefit from Paris and its western employment zones. Major national and international companies play a dominant role in the local economy (e.g., 3M, Rover, Clarins, Dassault, Siemen).

The University of Cergy-Pontoise (UCP) was created in 1991 within this dynamic framework. It is a French public Institution and a leading center of teaching and research that welcomes over 1,500 international students from 54 different countries out of a total student body of 15,000. With over 1,000 academic staff, the University offers all levels of undergraduate and post-graduate studies and has been ranked among the 20 best national universities. 144 Degrees are available in all areas of studies (except medical studies). The University is divided into 5 departments: Law, Economics and Management, Languages, Literature and Social Sciences, Science and Technology. Exchanges have been developed all over the world with over 135 foreign universities. The University also takes part in the European exchange program and has adopted the ECTS system (European Credit Transfer System) which allows European students to obtain credits in their university for courses taken abroad. UCP has been singled out as a "Model University" several times by the French government.

In keeping with its efforts to welcome foreign students and to develop international links, the School of Law has created an LL.M. in French and European Union Law taught in English. For the very first time this program offers foreign students and professionals who do not speak French the opportunity to acquire an advanced knowledge of French and European Union Law with a specialization in two major fields.

## About the LL.M. program

International exchanges and partnerships have revealed that, for various reasons, foreigners are interested in French and European Union Law. For both students and professionals knowledge of French and European Union Law is crucial for a successful career. Yet a French Law Degree requires a good level in French language.

For the first time UCP's School of Law offers a unique LL.M. program in French and European Union Law taught in English. It is aimed at graduates from non-French jurisdictions and foreign professionals settled in France or doing business with French partners eager to acquire a strong background in French and European Union Law.

To ensure quality, the LL.M. is selective and designed for law students who have a high level of legal studies and a very good level of the English language.

Students can choose one of the following specializations:

- ▶ LL.M. in Business & Taxation Law. This specialization offers students the opportunity to acquire a deep knowledge in Accountancy and Taxation regulation in France, Europe and abroad. The Taxation Law classes are taught within one of the most reputed Law Firm based in Paris.
- ▶ LL.M. in Law & Business Ethics. This specialization offers a unique knowledge of major issues in Ethics and Governance. Students enrolled in this program are affiliated to the Chair of Excellence in Law and Business Ethics and participate in all the activities.

Classes and seminars are taught by academics and by practitioners. The advantage of such an association is to offer students real contacts both inside the School of Law and among the legal community. Some seminars are taught by and within international firms based in Paris.

Each year, a two-day learning trip to the European institutions is organized. During this experience, students attend conferences held by experts of the European Commission.

Native English speakers enrolled in the program are also offered the opportunity to teach legal English classes to French students during the academic year.
